INTRODUCTION

Machine to machine (M2M) systems have been around for a long time. Remote telemetering, Supervisory Control and Data Acquisition (SCADA) and fleet monitoring are examples of M2M systems that have all been in use for several decades. In recent years, however, technological advances in M2M, declining infrastructure costs and excitement over the Internet of Things (IoT) have all served to reignite interest in the M2M sector, both in commercial and consumer markets. This report focuses on current trends in the commercial M2M market, including recent developments in technology, product and service delivery, business strategy, merger and acquisition activity and capital formation. While many M2M companies today tend to address specific industry verticals, for example smart metering in the utilities sector or fleet management in the transportation vertical, this report also aims to identify companies that are pursuing broader, more horizontally oriented addressable markets with solutions that operate across verticals. In addition, we believe there is a very large opportunity for companies to manage M2M systems and lock in annuity revenue streams through long term contractual relationships. We believe the best positioned companies, and premium sector valuations will be found in these two areas in the next few years.

THE M2M MARKET

DEFINING THE M2M MARKET

With M2M increasingly in the scope of industry reports worldwide, market definitions have broadened and can vary considerably depending on the source and context. In addition, terms such as IoT tend to get used in a variety of contexts that make market definition more challenging. We use the term **Machine-to-Machine** to describe technologies that enable devices to communicate with other devices over both wireless and wired networks. This includes networked connections and communications between devices or systems that are used to monitor activity, track and orchestrate movement, or transmit information about or assess the state of assets. The typical machine-to-machine process uses a sensory device to capture an event such as a temperature change, inventory datum, GPS signal or meter reading. Data is then relayed through a wired or wireless network, allowing other software applications to record and report the event.

It is important to distinguish between M2M and other Person-to-Person, Machine-to-Person, or general connected-person solutions. Although often included under the general heading of M2M, wireless messaging, such as SMS, MMS, A2P applications, as well as more traditional IT solutions, such as routers and servers commonly deployed in the data center and enterprise IT environments are not considered to fall within the boundaries of our definition of M2M. While there are a lot of M2M products and services aimed at the consumer market such as home automation and security devices, the focus of this report is on commercial and industrial applications for M2M technology. We don't doubt that the market for consumer M2M applications is not vast (as evidenced by Google's acquisition of Nest for \$3.2 billion last year), however long term we would expect commercial applications to have higher lasting value, being less subject to churn, obsolescence and commoditization than consumer markets.

M2M systems typically comprise hardware, software and communications services working hand-in-hand. M2M hardware includes a range of products from sensors, chips, bricks, and modules to SIM's, motor controllers, evaluation nodes, and traditional databases. Software solutions include traditional data collection and processing platforms, as well as cloud based and SaaS platforms, and other network automation applications. In addition to the collection and processing of data, many systems now also provide analytics and reporting capabilities. M2M uses various types of network communications for data transmission, including wireline, wireless, power-line, mobile phone, and satellite networks. Other services include integration and implementation, generally rendered on a per-project basis, as well as turnkey and outsourced managed services that some vendors are offering to generate long-term recurring revenue.



SIZING THE MARKET


According to Machina Research, at the end of 2013, there were approximately 3.6 billion connected M2M devices worldwide. Growing at a compound annual growth rate of 22%, this number is projected to increase to 26.1 billion in 2023. Using the definition presented above, 23% of all Internet connections were attributed to M2M in 2013. This figure is expected to grow to 61% by 2022. Global M2M revenue is projected to rise to \$ 1.3 trillion in 2022, increasing at a compound annual growth rate of 16% from \$300 billion in 2012. The United States will be the biggest global M2M market, accounting for 20% of revenue, alongside China with 17%. Other major markets will be Japan, Germany and Russia.

Looking at specific vertical applications, the Intelligent Buildings sector is expected to be one of the biggest M2M verticals by 2022. Dominated by solutions for power consumption and HVAC this sector is projected to make up 37% of all connections¹. M2M applications in the worldwide Oil & Gas industry are forecasted to grow at a compound annual growth rate of 21%, from 423,000 units in 2013 to 1.12 million units in 2018². The fleet management sector is expected to grow from \$10.9 billion in 2013 to \$30.5 billion by 2018², at a compound annual growth rate (CAGR) of 23%. Some analysts also forecast the automotive M2M market to grow at a CAGR of 29% over the period of 2014 to 2018. Researchers in precision agriculture predict that, besides large expected revenue increases for farmers and smaller businesses, over \$20 billion of increased revenue for large companies, such as Monsanto, Syngenta and BASF SE². Within the utilities sector, 'smart water' represents a huge growth opportunity and is expected to generate up to \$18 billion in revenues in Europe alone. The healthcare industry is expected to benefit immensely from growing M2M solutions cutting costs and Big Data solutions reducing the complexity of a fragmented industry with many participants (i.e. hospitals, ambulatory clinics, laboratories). Digital monitoring technology is therefore projected to initially save the US healthcare system up to \$1.4 billion³.

MARKET TRENDS

GROWTH DRIVERS

A confluence of trends is combining to drive double-digit projected annual growth over the next several years. We believe a big driver of growth in the commercial sector are successful deployments delivering tangible returns, which in turn is driving more activity, however factors such as lower infrastructure costs, greater network availability and more sophisticated functionality are also playing critical roles in making M2M more accessible to a broader market.

High return on investment While M2M might have been a nice to have technology a few years ago, we believe the ROI story is becoming too compelling to ignore. More and more payback periods are being measured in weeks and months instead of years. At a high level, the payback analysis on M2M usually involves some saving in human resource cost, such as a site visit, a truck roll or a manual process of some kind. In many cases M2M applications are able to take on tasks that would be unfeasible economically or logistically if attempted by human resources. We have been surprised by the magnitude of the ROI math in specific cases, for example power savings of 30-40% for smart lighting systems, and total operating expense savings of 5-10% for utilities managing remote site infrastructure. Over a large scale operation involving multiple sites, this can translate into tens if not hundreds of millions of dollars in annual savings. Proving out the ROI has knock-on effects that also are fueling growth:

- Companies that have tested M2M systems on a limited basis with successful results are now deploying on a larger scale.
- There is increasing motivation to deploy more sophisticated applications.
- Success of one company drives adoption by competitors and makes M2M a need to have in order to remain competitive.

Lower Infrastructure Cost There is no doubt that declines in the cost for basic sensor equipment have helped the ROI math, especially for highly distributed applications such as in the utilities and automotive markets. In the last two years alone an 8% decline in average sensor prices has driven sales volumes by nearly 25%³. Lower prices not only improve the return on a given system, but as sensors tend to be placed at the periphery of the typical M2M deployment, they can also justify larger systems utilizing more sensors over a larger geographic footprint. Improvements in battery technology that have increased the life of remote sensors are also driving costs down, improving reliability and enabling larger deployments. In addition to sensors, server, switch and routing costs are all coming down as competition intensifies in these markets and as more and more M2M systems make use of off the shelf rather than proprietary equipment. The establishment of industry standards, still at a relatively nascent stage (see *Challenges* below), should in the future provide an additional boost to lower infrastructure costs through the use of interoperable, standardized components.

Higher Network Availability No less important as a growth driver in the M2M market is the increasing degree of network availability. There are three dimensions to this:

- Increases in mobile network coverage as operators continue to add coverage in previously unserved areas
- · Higher bandwidth availability with successive generations of wireless technology such as 4G LTE
- More wireless spectrum being assigned to commercial use

A fourth element perhaps is lower unit pricing for network usage as competition intensifies and operators seek to enhance existing services and enter new markets to generate revenue growth. Taken together, these trends serve to make M2M network connections cheaper, more ubiquitous and more reliable. Higher network reliability in turn enables systems to manage more mission critical applications.

More sophisticated applications As infrastructure costs come down, applications are becoming more ambitious. Take for example a traditional RFID asset tracking system designed to monitor the location and movement of particular assets. As costs have declined, the sophistication of technology has increased, such that today's RFID systems can also track not only location but also the state of assets including things like temperature, humidity, moisture, flow, seepage, breakage, and theft. Newer systems can also provide richer, more recent data as well as trending analytics, enabling a more complete view of managed assets. With sufficient bandwidth available at the edge of the network, it might also be possible to provide a real time video feed. increasing the size and frequency of the data streams.

Control Systems Many M2M systems provide one-way monitoring data, for example sensors sending periodic GPS location data for shipping containers as they make their way across the ocean, or a sensor monitoring fuel tank level at a remote site. While this data can certainly be useful, we believe the greatest value in M2M lies in systems that provide both monitoring and control capabilities. Benefits are several, including:

- Saving time and expense of dispatching crews to remote sites
- Providing immediate detection and response before problems reach critical or irrreversible status
- Enabling preventative maintenance, and in the process extending useful asset life
- Controlling a larger footprint with greater efficiency and limited human resource requirements
- Optimizing use of resources, both at the remote site and in the entire operation
- Gathering and analyzing richer data from a larger number of sites

The concept of remote control has roots in SCADA systems which have been in operation for years, primarily in the oil & gas, utilities and manufacturing sectors. Historically, SCADA systems delivered data on closed networks using proprietary protocols and hardware, and as a result their scalability and payback was limited. Newer monitoring and control systems are able to use off the shelf hardware and cheaper, commercially available network connections, making them both less expensive to deploy, cheaper to run and generally more flexible and interoperable when changes need to be made. In addition, the reliability and security of readily available components is often greater, ensuring smoother operations once the system is deployed.

Automotive Segment The size, growth and overall interest in the automotive M2M market deserve special mention. Within the last 15 years, auto manufacturers have leveraged GPS, mobile network and M2M technologies to provide more sophisticated, multi-function computer systems inside cars and trucks. Sometimes referred to as telematics, these systems provide a range of M2M data used by insurance companies, government entities, logistics providers and vehicle manufacturers themselves. On-board computers are linked to sensors which collect vehicle system diagnostic data such as emissions monitoring, fuel consumption and possibly other inputs regarding driving behavior such as speed, braking and cornering data. They can also provide key forensic information in the event of a malfunction or a crash, much like the black box in aircraft. These systems also are used for a growing range of Machine to Person (M2P) applications as well, including GPS navigation, emergency roadside assistance, stolen vehicle protection and in-vehicle entertainment.

Automotive M2M is drawing strategic attention from a number of industry players, including mobile network operators who are well positioned to benefit from the segment's large scale and growth. It is projected that approximately 104 million new cars will have some form of connectivity by 2025⁴. Revenue is also expected to grow, however, through the provision of an broadening array of services. In particular, 4G mobile networks enabling vehicles to become their own Wifi hotspots, open up a host of subscription-based freemium and premium service and entertainment opportunities.

Perhaps the best evidence of the strategic interest in automotive M2M was embodied in the acquisition of Hughes Telematics by Verizon in July, 2012 for \$713 million in enterprise value. The transaction was valued at more than 9x trailing 12-month revenue, and two years later remains the largest transaction to date in the commercial M2M sector. Other notable deals in the automotive segment include the Fleetmatics IPO in October 2012, which raised \$133 million in gross proceeds and valued the company at \$585 million, and the \$93 million private financing for Telogis led by Kleiner Perkins Caufield & Byers (See *Private Financing* below).

CHALLENGES

For all the promise and growth potential of M2M, serious impediments to broader deployment remain. These include:

Connectivity As the value of M2M becomes more fully realized and the sophistication of applications increases, so does demand for higher bandwidth at remote locations. While 4G and LTE are increasing network capacity in more populated areas, the most ubiquitous networks, such as LEO satellite networks, typically provide limited bandwidth and their inherent latency precludes them from use in which in real time or rapid response is critical. With the prediction that 61% of all Internet connections will be ascribed to the global commercial and consumer M2M markets by 2022, many are predicting that limitations in wireless spectrum, as well as the number of available IP addresses, could constrain growth. Fortunately, FCC plans for increased spectrum availability, including unlicensed frequencies in the TV White Space for example, as well as the recent introduction of IPv6, are expected to alleviate these bottlenecks for the foreseeable future.

Communications networks and analytics engines now also need to be able to handle the increased flow of data. Higher application sophistication generally requires more signal processing at the network perimeter as well as a higher bandwidth network connection to transmit richer content.

Security An estimated \$35 billion is spent annually on software and related services to secure IT assets from digital threats, including viruses, malware, spyware, hacks, and other types of attacks. The vast majority of this technology is designed to protect interactions between machines and people. But as the number of connected devices, and the underlying value of M2M assets, continue to grow, so does interest by nefarious forces and the likelihood of serious security issues. More and more M2M systems are being run on common operating systems prone to security vulnerabilities. Moreover, given the lack of human involvement, and the rise of more insidious attacks such as Advanced Persistent Threats, security breaches in M2M environments may be particularly hard to detect. Hacking a vending machine may be one thing, but hacking a smart building system or a water treatment facility could endanger high value assets if not human lives. Recall the disabling of automated networks at Iran's Natanz nuclear facility two years ago and the magnitude of the problem now looms. Security issues are not limited to just to the communications network but extend also to protection and encryption of transmitted data.

Industry Standards One of the biggest impediments to broader adoption lies in the creation and adoption of standards for uniform data transmission protocols and system interoperability. Because many of the M2M systems in use today were created within the context of a specific application and often a single vertical, a large number of existing protocols are essentially proprietary. Standardization enables hardware and software vendors to expand their addressable markets and reduce the number of products. For customers, standards help to expand the number of vendors, keep costs down and ensure availability of needed components. A few examples of the existing protocols and standards being developed or in use today are listed below:

- IEEE 802.15.4 Standard specifying the physical layer and media access control for low-rate wireless personal area networks. It is the basis for the Zigbee, ISA 100.11a, WirelessHART and MiWi specifications.
- Zigbee Standard of communication protocols based on an IEEE 802.15 and used in mesh networking environments. ZigBee devices are designed for low power and data transmission over long distances.
- ISA100.11a Wireless networking technology standard developed by the International Society of Automation (ISA) for implementing wireless systems in the automation and control environment with a focus on the field level.
- WirelessHART Wireless sensor networking protocol based on the Highway Addressable Remote
 Transducer (HART) Protocol, supporting operation in the 2.4 GHz ISM band using IEEE 802.15.4
 standard radios and based on the work of Dust Networks' TSMP technology.
- MiWi and MiWi P2P Proprietary wireless protocols using small, low-power digital radios based
 on the IEEE 802.15.4 standard and designed for low data transmission rates and short distances
 such as in industrial, building automation and telemetering applications.
- 6LoWPAN IPv6 over Low power Wireless Personal Area Networks are standards developed to
 connect low power devices using ipv6 over IEEE 802.15.4 based networks. Thread, a standard
 developed by Google Nest and other home automation companies, is based on 6LoWPAN.
- **Z-Wave** Low-power RF wireless protocol designed for remote control applications in residential and light commercial environments, such as lighting, access control, entertainment systems and household appliances.
- DASH7 Open source RFID standard for wireless sensor networking which operates in the 433 MHz unlicensed ISM band/SRD band. DASH7 provides multi-year battery life, range of up to 2 km, indoor location with 1 meter accuracy and low latency for connecting with moving things.

In addition, there are a number of industry consortia such as OneM2M that are developing technical specifications for a common M2M Service Layer that can be embedded in hardware and connect the myriad devices in the field with M2M application servers.

BUSINESS STRATEGY OVERVIEW

As noted above, operational M2M systems typically comprise a mix of:

- Hardware, usually in the form of sensor and switching/routing equipment to generate and direct information flows
- Software to orchestrate the data flow and provide centralized monitoring and control
- Services, both for communications connectivity as well as integration services



As a general observation, vendors in the M2M ecosystem traditionally have tended to offer one of these three components of an operational system. For example, many of the largest companies in the M2M sector are providers of sensor hardware, including 3M, Emerson and Honeywell. In addition, many of the network service providers such as telecom, satellite and mobile network companies are also large companies such as Verizon and AT&T.

By contrast, companies providing full turnkey systems have tended to be both smaller in size and vertically oriented. There are a number of companies for example, providing solutions in specific markets such as utilities and oil and gas for example, and their solutions are designed around the specific needs of those verticals. Examples include Telular in the chemical and water treatment areas, and American Innovations in oil & gas.

As the scale, sophistication and complexity of M2M systems continues to increase however, we believe there is a growing unmet need for turnkey systems that are easily implemented, use off the shelf components, and can be deployed for a wide range of applications across multiple industries. With connectivity as their core offering, the major telecom providers in particular are well positioned to offer turnkey solutions and many are building or acquiring expertise to deliver end to end solutions in specific verticals. Much of their focus to date has been in the consumer market, for example in home security and automation, and some carriers are now developing offerings in key commercial markets such as energy, utilities and building security.

Some of the companies that traditionally have focused on hardware have moved in the direction of managed services and solutions. Sierra Wireless, for example, sold its AirCard USB device business in early 2013 in order to concentrate on the M2M market opportunity. While its core revenue generators today are comprised of embedded wireless modules, gateways and tools for a range of M2M applications, it also has a rapidly growing Enterprise Solutions business built on the company's own cloud-based platform for building, deploying, and managing a broad range of M2M applications in several industries, including the transportation, oil & gas, industrial and retail verticals. At Digi International, while the majority of revenue continues to come from the sale of hardware products including cellular routers, wireless gateways, adapters and modules and other components, the company's services revenue has more than doubled in the last three years alone, from 5% of total revenue in 2011 to over 11% in 2013. This growth has been driven in large part by the company's cloud based Platform-as-a-Service offering. In 2006, Numerex was predominantly a provider of hardware, with 2/3 of its revenues derived from the sale of sensor, data link, RF and other types of equipment used in M2M applications. Today 2/3 of the company's revenue comes from recurring subscription and support revenue generated in connection with managed service bureau and cloud offerings. These offerings incorporate hardware, software and connectivity to deliver turnkey solutions designed for interoperability, rapid deployment and ease of use.

Today, there are very few pure-play M2M companies offering universal, turnkey cross-industry platforms, however the establishment of industry standards is creating opportunities for companies to do so. Those that do exist and are achieving scale above \$50 million in revenue or more are in our estimation particularly well positioned to attract investor and strategic interest, due to inherently larger addressable markets and more compelling, one-stop-shop value propositions. In addition, by offering platform technology on a subscription basis, some of these vendors are able to lock in long term annuity revenue stream as managed service providers, in some cases for 10 years or more.

There are a handful of emerging companies founded to offer open platforms for turnkey solutions which combine data collection and management software with integrated network connectivity across multiple carriers. Large scale deployments might, for example, use a combination of terrestrial mobile networks and satellite communications depending on location, cost, coverage and bandwidth requirements. By offering customers a seamless connectivity solution across geographies and network types, companies such as Kore Telematics, Raco Wireless and Wireless Logic help companies solve the difficult problem of providing secure, reliable connectivity across extended M2M systems that by their nature require connections to heterogeneous networks and network types. In doing so, they enable more complex, larger scale deployments, and by being able to integrate many types of hardware, they are also creating the industry's first horizontal platforms supporting M2M solutions across multiple industries. Strategic interest could come from large industry players seeking vertical integration and recurring revenue, or potentially from the network service providers themselves.

Other notable companies offering vertically-agnostic solutions include LivingPlanIT, which has created and is now actively implementing an operating system for M2M applications, and Elbrys Networks which has created a unique middleware product designed for open interconnection of myriad devices in both commercial and consumer markets. Both of these companies are included in the Sector Spotlight later in this report.

OVERVIEW

As we noted in our earlier report, with the advent of Internet of Things (IoT), investor enthusiasm in the Machine to machine (M2M) market has been very strong. The IoT trend has even caught the fancy of technology giants such as Apple and Google, who are reportedly working on projects ultimately aimed at connected car technologies. For the period 2010-2015 (YTD April), we have shortlisted 176 deals in the M2M space with the cumulative deal valuations at \$4.5 billion. The deal volumes were highest in 2013, although deal values were the lowest at \$395 million during the period.

VALUATION TRENDS

The mean M&A deal valuation for last twelve months (LTM) revenue has been in the range of 1.5x-2.3x over the last five years (2010-2014). For the corresponding period, excluding 2010, the mean EBITDA multiple has fluctuated in the 12.7x-25.8x range. Although the valuations, namely EBITDA multiples, are based on a small sample size, the significantly high EBITDA multiples in some cases reflect the strategic nature and expected synergies from the deals. We believe the rising level of deal sizes has manifested in the median deal value for 2014 reaching \$25.0 million, which is the highest level achieved in the past five years.

Although LTM valuations were unavailable for some of the key deals which were announced post the release of our last report, the available information has allowed us to calculate and offer our insights into some of the deal valuations. As an example, the Sierra Wireless-Wireless Maingate deal announcement reflected a valuation of 4.7x Maingate's estimated 2014 revenue and 15.0x estimated 2014 EBITDA. The ORBCOMM-SkyWave deal (announced in November 2014) was consummated in January 2015 at 2.1x estimated 2014 revenue and 10.4x estimated 2014 EBITDA.

2015

In April 2015, Cleeve Capital announced a reverse acquisition of Satellite Solutions Worldwide for GBP5 million (approximately \$7.4 million) in shares. In the same month, DriveFactor, a provider of insurance telematics services, was acquired by an unnamed strategic buyer for \$22 million. Although deal multiples are not available for most deals in 2015, the deal for OMNISYSTEM Co, a manufacturer and seller of automatic meter reading systems, was announced for 1.0x revenue and 10.2x EBITDA.

2014

Since our last report published in August 2014, consolidation activity in the M2M space has remained robust, clocking 36 deals during the calendar year and recording the highest deal value during the last five year period at \$1.45 billion. The mean revenue deal multiple for the full year was 1.6x, higher than the 1.3x multiple when we last published the report, indicating that the latest deal announcements have been at higher multiples.

In November 2014, in a major deal announcement, ORBCOMM agreed to acquire SkyWave Mobile Communications in a bid to become the largest global space-based M2M communications company. The strategic deal provides ORBCOMM with new M2M solutions, economies of scale and access to new geographies and verticals. Under the terms of the agreement, ORBCOMM would acquire SkyWave for \$130 million including \$122.5 million in cash from ORBCOMM and \$7.5 million in promissory note to Inmarsat for a portion of its interest in SkyWave. Along with the deal announcement, ORBCOMM announced a \$72 million public offering of its common stock to part finance the deal. According to ORBCOMM's investor presentation, the deal provided estimated annualized synergies of \$2-4 million. Based on the mid-point of pre-synergy and post-synergy SkyWave's 2015E EBITDA contribution, the estimated transaction multiple was 9.0x pre-synergy and 7.0x post-synergy. Based on the mid-point of SkyWave's 2014E numbers as disclosed by ORBCOMM in its investor presentation, the deal was valued at 2.1x revenue and 10.4x EBITDA. According to data from Capital IQ, the corresponding LTM deal multiples were 1.4x revenue and 8.1x EBITDA.




In December 2014, Canada-based M2M devices and cloud services provider, Sierra Wireless agreed to acquire Wireless Maingate, a Swedish provider of M2M connectivity and data management services for \$90 million in cash. The relatively high deal valuation of 4.7x estimated 2014 revenue and 15.0x estimated 2014 EBITDA was reflective of Maingate's recurring revenue and its strategic fit to Sierra, considering opportunities for market expansion and customer additions across Europe. Moreover, Sierra expected the deal to be immediately accretive to earnings upon completion.

In November 2014, Lindsay Corporation agreed to acquire Elecsys Corporation, a provider of M2M technology solutions and custom electronic systems. In January 2015, Lindsay completed the deal for \$70.5 million in cash, including equity compensation awards. The deal valuation of 2.3x LTM revenue was relatively higher when compared to other disclosed deal valuations in 2014 and the mean deal valuations in the preceding two years.

In November 2014, ABRY Partners, a private equity investment firm focused on the communications sector, acquired a majority stake in KORE Wireless Group, a provider of M2M solutions for an undisclosed amount. Shortly thereafter, KORE announced the acquisition of RacoWireless, a provider of software and cloud services for deploying and managing M2M services, for an undisclosed amount in an all-cash deal. The deal enabled KORE to build enhanced scale and consolidate its leading footprint in the US.

GEOGRAPHIC SPLIT

In this report, we have presented the geographical split for the last six completed years. The trends in 2014 for the geographical split remained in line with our observations in the last report. North America and Europe continued to dominate the M2M M&A space, accounting for just above 80% of both, deal volumes and deal value, with deal values in North America consistently above \$100 million. Interestingly, in 2014 the deal value in Europe jumped to \$720 million, its highest level since \$209 million achieved in 2010. In contrast, deal values in North America reached \$459 million, well above the \$360 million recorded in 2013. Amongst other regions, Asia-Pacific accounted for \$266 million in 2014, surging past the \$6 million achieved in 2013.



The Customized Public M2M Index has largely outperformed the S&P 500 Index and the NASDAQ Composite Index during the major part for the last three years. However, in the last few months, the Customized Public M2M Index has largely retracted and its performance now is in line with the NASDAQ Composite Index. We believe this trend reflects the reduced level of investor enthusiasm surrounding the M2M space amidst disappointing results in the M2M space by major players in the space such as Novatel Wireless and Gemalto (heavy weightage in the index). We note that since our last report, we have removed some of the stocks from the customized index following their acquisition or delisting from the exchange for example Elecsys Corporation.

PUBLIC COMPANY ANALYSIS

Some of the publicly traded companies continue to trade at significantly high valuations mirroring their robust growth prospects example Novatel Wireless and ORBCOMM (Price-to-Earnings and Price-to-Sales multiples well ahead of the median valuations for the sector). We note that even niche players such as Inmarsat also trade at relatively high valuations, despite having subdued top-line growth prospects.

PRIVATE PLACEMENTS 2012-2015 (YTD APRIL)


The M2M private financing activity has picked up significant pace in the past couple of years as players have sought increased access to funds to grow their business, amidst rising awareness of the potential of the technology. For the period 2010-2015 (YTD April), we have shortlisted 141 deals with cumulative financing of approximately \$1.5 billion. We note that the private financing activity has witnessed the highest number of deals and the largest amount of capital raised in 2013 at 34 and \$692.8 million, respectively. In 2014, the number of private placement transactions was close to but slightly below the levels achieved in 2013, while the corresponding total capital raised fell to \$250 million. We note that the single largest private placement deal during the entire five-year period under observation was the \$400 million financing by Mobileye, a leader in the area of driver assistance systems in 2013. Removing the \$400 million Mobileye financing, the amount of capital raised in 2014 was only slightly less than the 2013 amount.

In 2015 (YTD April), the amount of capital raised has jumped to \$271.6 million on 19 deals announced within the first four months of 2015. The trends in 2015 (YTD April) reflect a huge jump in the average transaction size to \$16.0 million from \$9.6 million for the full-year 2014. The largest deal announced in 2015 so far has been the private financing deal for \$115.0 million involving French startup firm Sigfox, which builds low-cost networks to enable IoT applications. The investors in this round of funding included Elliott Management and some major telecom and utilities companies including Telefonica, GDF Suez, SK Telecom and Air Liquide, amongst others. In October 2014, Sigfox, which aims to offer an alternative low-cost grid to a mobile phone network for more efficient M2M connectivity, announced plans to raise €50 million. In the past, Sigfox's CEO, Ludovic Le Moan has claimed that the company may aim for an IPO in 2016 if it successfully secures contracts from major US telecom players. The \$88.7 million financing raised by Jiangsu Hoperun Software in April 2015 was the second-largest deal of the year so far.

Although the median deal size for private placements has ranged between \$2.0-5.0 million in the last five years, currently the median deal valuations have been at \$1.1 million. Correspondingly, the average transaction size in the last five years has been in the range of \$5.2-\$21.7 million. The average deal size for 2015 is the second-highest in the past five years, due to the Sigfox deal.

GEOGRAPHIC SPLIT

Similar to the trends observed in M&A, even in the private placement space, North America and Europe accounted for more than 80% of the deal volume and deal values in 2014. Although, in the past few years, the private placement activity in the M2M space has witnessed some fluctuations, it has still been largely dominated by these two regions.
