




Manchester United's (-12.9%) stock fell in June as majority shareholders continue to pay themselves multi-million GBP dividends despite financial losses expected to continue through 2024


DraftKing's (-13.9%) stock fell in June despite strong revenue growth as losses continue to exceed expectations amid shaky market with amplified focus on near-term profitability

Enthusiast Gaming's (-17.8%) stock fell in June amid a lack of confidence in CEO Adrian Montgomery, with key executives citing failures around strategic planning and threats to Enthusiast's long-term well-being
